Before you leave, you will receive a copy of your tax return before authorizing the electronic filing of our return.

You will need to contact them to schedule an appointment and request a Tax Aid packet. The packet will be mailed to you in advance and must be completed prior to the appointment. Please complete and sign the intake form and bring with you. **Please note**, we are no longer able to do returns for taxpayers with Minnesota income.

We WILL need each person to bring last year's taxes and all the income sheets, 1099s, W2's, etc., property tax and/or rent certificates with them when they come the first time. Please check last year's taxes to be sure all information is complete.
